Note 1 - ORGANIZATION AND SIGNIFICANT ACCOUNTING POLICIES

Groundswell International, Inc. is a partnership of local NGOs and resource people in Latin America, Africa and Asia, coordinated by a global office based in the U.S., working to strengthen capacity for positive social change in rural communities.

The following is a summary of the significant accounting policies of the Organization.

- a) Basis of Accounting - The accompanying financial statement were prepared on the accrual basis of accounting
- b) Income Tax - The Organization received confirmation of it's exemption from federal income taxes under Section 501c(3) of the Internal Revenue Code on August 5, 2010.
- c) Revenue - The Organization's revenue related to contributions received are recognized as revenue in the period received at their fair values and the Organization distinguishes such contributions received for each net asset category in accordance with donor-imposed restrictions.
- d) Financial Statement Presentation - The Organization's financial statements adhere to the established standards for external financial statements provided by not-for-profit organizations which require that resources be classified for accounting and reporting purposes into three classes of net assets - permanently restricted, temporarily restricted, and unrestricted.
